## Terms of subscription

Reservation and payment clause:

- 1- After signing this contract, the subscriber shall pay the full cost of the booth before the date of 10/02/2020 (before midday). The prices mentioned include the booth and 2 visa, accommodation and transportation to and from the exhibition.
- 2- Priority in the reservation of space and location for those who book and pay the fees first and will not be accepted after the completion of entries.

### Obligations and Liability clause:

1. The exhibitor shall be committed to all expenses necessary to return the booth to the original for any part of the area of the unit as long as the change or damage to the place because of the act and in general also bears the payment of the value of any damage caused on any image, which affects the decor of the place and must be Pay this amount according to what the organizer estimates with the agreement of the building officials.
2. Any damages caused by (Exhibitor) in anything owned by (organizer) as a result of the change made by (Exhibitor) and paid directly to the organizer (as determined by him without delay in payment).
3. Fully abide by the law of the host country and take responsibility for violating the laws.
4. The exhibitor is obliged to pay all kinds of taxes and / or customs imposed and any fees or fines imposed as a result of his participation and any fines or violations as a result of his participation or because of it as well as because of any defect in origin.
5. The exhibitor is fully committed to all instructions issued by the organizers and the exhibition management.
6. The organizers are not responsible for the management of the pavilion of the participating companies or the volume of their sales or how they manage their pavilion or the employees / exhibitors hired by the participating company.

**Insurance clause:**

The organizer shall not be responsible in any way for insuring the exhibitor's exhibits whether in terms of loss or loss due to theft, arson or any other reason whatsoever. In case of cancellation of participation by the exhibitor 60 days before the date of the exhibition will be deducted 50% of the participation fees and become a right of the organizer, and if canceled by the participant 40 days before the date of the exhibition will be deducted 75% of the participation fees If canceled 30 days before the date of the exhibition, the organizing company has the right to withhold all the value
