Subscription conditions

Reservation and payment clause:

- 1- After signing this contract, the subscriber must pay the full cost of the hut three months before the Forum. The prices mentioned include the stand, visa, accommodation and round-trip transport.
- 2- Priority in the reservation of space and place goes to those who book and pay the fees first, and those who come after the end of registration will no longer be accepted.
- 3- Transfer the total amount to the bank Account Number mentioned below in the name of IECO International for the Organization of Exhibitions and Conferences, which is the organizer of the forum. When you transfer or pay the full cost of the stand, surely you need to sign a contract between us:

Obligations and Liability Clause:

1- The exhibitor is liable for all the costs necessary to return the booth to the original for the whole part of the unit area, as long as the change or damage to the place was due to an act, and that he also supports in general, the value of all damage occurring on any image, which affects the decor of the place, and it must pay this amount according to the estimate of the organizer with the approval of the building officials.

2. Any damage to something caused by the exhibitor, belonging to the organizer, as a result of the modification made by the exhibitor, is paid directly to the organizer (as determined without delay of payment).

3. Comply fully with the law of the land and take responsibility for the violation of laws.

4. The exhibitor is required to pay all types of taxes and / or levies collected, as well as any costs of fines imposed as a result of his participation and of fines or violations resulting from or because of his participation as well as any defect in the original.

5. The exhibitor fully agrees to comply with all instructions given by the organizers and the Exhibition Management.

6. The organizers are not responsible for the management of the cabins (huts) of the participants, the companies or the volume of their sales, or how they manage their huts, or the employees / exhibitors hired by the participating company.

Insurance Clause:

The organizer is in no way responsible for insuring the exhibitor's exhibitions, whether in terms of loss, or loss due to theft, arson or any other reason. Therefore, the exhibitor should protect his exhibits by protecting them as much as possible. Hence fire insurance or any other damage or theft is the responsibility of any bidder at its own expense.

Unit design and construction Clause:

The organizing company is responsible for the construction, design of the stand and its complete preparation for the exhibitor. If the exhibitor wishes to design, build and equip his unit, he must obtain the written certificate of approval and signed by the organizer. The organizer has the right to approve or refuse within the limits of what he considers appropriate for the exhibition.

Cancellation or postponement Clause:

1. In case of cancellation of participation by the exhibitor 60 days before the date of the exhibition, 50% of the participation fees will be deducted and will become a right of the organizer. In case of cancellation by the participant 40 days before the date of the exhibition, 75% of the participation fees will be deducted. In case of cancellation 30 days before the date of the exhibition, the organizing company will have the right to retain all the value.

2. The company IECO (International pour the Organization of Exhibitions and Conferences) may cancel or postpone the exhibition for any reason whatsoever, assuming legal, financial or other responsibility, with the obligation to reimburse the amount paid by the exhibiting company.
